### **Trustee biographies relating to the resolutions**



**Anne Davis** is a Chartered Accountant, with over 25 years experience in strategy, governance, risk, compliance, regulation and change management across a wide variety of sectors. She has been a trustee and chair of several charity boards in the wellbeing, health, and social care sectors.

Most recently, Anne was Associate Director for RSM UK, where she had oversight responsibility for anti-money and sanctions compliance to mitigate legal and regulatory risks. Prior to that she had various senior roles in professional accountancy bodies. She also has experience of charity accounting, membership support, stakeholder engagement and government policy making.

Anne's youngest son has coeliac disease. As a result, she is aware of the challenges associated with the disease and is a strong advocate of improving the accessibility of gluten free food at home and in the retail and hospitality industries.



**Kate Denham** is a charity and public sector strategy specialist with 16 years' experience supporting organisations with social purpose to 'do good better.' Kate is the former Group Head of Strategy for the RNIB - one of the largest charities in the UK. She now runs The Public Good Company, working at executive level with a range of charities, local government, health and membership organisations. She started her career in investment banking and strategy consultancy after completing her degree in Politics, Philosophy & Economics at the University of Oxford.

Kate is also an experienced Board member and trustee. She is currently a Secretary of State appointed board member for both Transport Focus and the Coal Authority, specialising in advising on risk, strategy, and transformation of service delivery for the 21st century. She was previously on the board of Babyzone UK – an early year's charity, Accelerate CIC - a nurse-led social enterprise, St Martin of Tours Housing Association and Healthwatch Croydon. She also sits on the Office of Rail and Road Consumer Expert panel ensuring policy is designed to reflect the needs of all rail and road users.

Kate is mum to two children, including her son who was diagnosed with coeliac disease before his fourth birthday. Given the relatively early diagnosis, Kate is enthusiastic about the idea that there could be a meaningful research breakthrough during the course of her son's life which would make a significant difference and render gluten free living no longer necessary.



**Miranda Sheffield** is an Investment Director at Bridgepoint, a private asset growth investor specialising in private equity and private debt. She spearheads the introduction and integration of applications, guiding their adoption and ensuring their effective use. Her strategic oversight extends to data management and governance, encompassing the delivery of data platforms, the execution of data analytics, and the generation of comprehensive reports.

Miranda has 15+ years of experience in delivering technology and data solutions to a wide range of business teams, from core operational company-wide platforms to small bespoke applications designed to meet niche business requirements. She has supported both internal and external audits and regulatory reporting requirements throughout her career.

Miranda was diagnosed with coeliac disease in 2013 following dramatic weight loss and severe anaemia. Miranda hopes to use her skills and experience to support the charity's technology and business strategy. Having been misdiagnosed for 12 years, Miranda is particularly keen to continue to raise awareness and improve diagnosis rates of coeliac disease.
